## **CONSULTATION**

- a) S.19/2200/LBC. Stokescroft, Cossack Square, Nailsworth, Stroud. External land drain, repairs to stone flag floor and sash windows, alterations to stud partitions, opening old doorway.
- b) S.19/1981/HHOLD. Hybank, Burma Road, Forest Green, Nailsworth. Resubmission of S.19/0607/HHOLD two storey side extension and porch.
- c) S.19/2076/HHOLD. 1 Springhill Crescent, Nailsworth, Stroud. Erection of a steel stove flue on the gable end of the property.
- d) S.19/1434/FUL.Land At, Ringfield Close, Nailsworth, Gloucestershire. Demolition of all existing site structures and the erection of 20 affordable residential properties including access, parking, landscaping and private amenity space
- e) S.19/2256/LBC. Egypt House, Stroud Road, Nailsworth, Gloucestershire. Removal of secondary staircase and reinstatement of 3 principle rooms.

- f) S.19/2204/TCA. The Squirrels, Theescombe, Amberley, Stroud. 2 x Silver Birch to be dismantled to ground level.
- g) S.19/2260/TPO. Beaudesert Park School, Box, Stroud, Gloucestershire. Copper Beech (T987) -Reduce the height of the tree by approx. 4.0m. Reduce the lateral spread of the crown by 2.0m all round. Remove significant dead wood and generally shape.

h) S.19/1626/HHOLD. New hard standing car park area and associated landscaping - Watledge Lodge Watledge Road Nailsworth Stroud Gloucestershire GL6 0AU. NTC; No objection raised. SDC decision; Application Permitted.
