# **Safeguarding Policy and Procedure (Child and Vulnerable Adults)**

### **1. Introduction**

Nailsworth Town Council makes a positive contribution to a strong and safe community and recognises the right of every individual to stay safe. Nailsworth Town Council comes into contact with children and/or vulnerable adults through the following activities:

- Delivery of services
- Involvement in activities within our properties
- Volunteer workdays
- General contact

This policy seeks to ensure that Nailsworth Town Council undertakes its responsibilities with regard to protection of children and/or vulnerable adults and will respond to concerns appropriately. The policy establishes a framework to support paid and unpaid staff in their practices and clarifies the organisation's expectations. The Town Clerk is the Child Protection and Vulnerable Adult representative to whom any suspicions or concerns should be reported.

### **2. Legislation**

The principal pieces of legislation governing this policy are:

### **3. Definitions**

Safeguarding is about embedding practices throughout the organisation to ensure the protection of children and vulnerable adults wherever possible. In contrast, child and adult protection is about responding to circumstances that arise.

Abuse is a selfish act of oppression and injustice, exploitation and manipulation of power by those in a position of authority. This can be caused by those inflicting harm or those who fail to act to prevent harm. Abuse is not restricted to any socio-economic group, gender or culture. It can take a number of forms, including the following:

- Physical abuse
- Verbal abuse
- Sexual abuse
- Emotional abuse
- Bullying
- Neglect
- Financial (or material) abuse

Definition of a child

A child is under the age of 18 (as defined in the United Nations convention on the Rights of a Child).

Definition of Vulnerable Adults

A vulnerable adult is a person aged 18 years or over who may be unable to take care of themselves or protect themselves from harm or from being exploited.

This may include a person who:

- Is elderly and frail
- Has a mental illness including dementia
- Has a physical or sensory disability
- Has a learning disability
- Has a severe physical illness
- Is a substance misuser
- Is homeless

#### **4. Responsibilities**

All staff (paid or unpaid) have responsibility to follow the guidance laid out in this policy and related policies, and to pass on any welfare concerns using the required procedures.

We expect all staff (paid or unpaid) to promote good practice by being an excellent role model, contribute to discussions about safeguarding and to positively involve people in developing safe practices.

Nailsworth Town Council has responsibility to ensure:

- The policy is in place and appropriate
- The policy is accessible to all members of staff
- The policy is implemented
- The policy is monitored and reviewed on an agreed time scale or when changes are made to any of the legislation relating to this policy
- Sufficient resources are allocated to ensure that the policy can be effectively implemented
- That the policy is appropriate to promote the welfare of children and vulnerable adults

- Ensure all staff have access to suitable training
- Any volunteers working for the Town Council and having unsupervised access to vulnerable users (eg. Running children’s entertainment) will be required to be DBS checked
- The lead officer is The Clerk to Nailsworth Town Council
- Receive staff concerns about safeguarding and respond to all seriously, swiftly and appropriately
- Keep up to date with local arrangements for safeguarding and DBS
- Develop and maintain effective links with relevant agencies

## **5. Implementation Stages**

The scope of this Safeguarding Policy is broad ranging and in practice, it will be implemented via a range of policies and procedures within the organisation. These include:

- Grievance and disciplinary procedures – to address breaches of procedures/policies
- Health and Safety policy, including lone working procedures, mitigating risk to staff and clients
- Equal Opportunities policy– ensuring safeguarding procedures are in line with this policy, in particular around discriminatory abuse and ensuring that the safeguarding policy and procedures are not discriminatory
- Data protection (how records are stored and access to those records)
- Reporting accidents and incidents

## **6. Communications training and support for staff**

The Personnel committee commits resources for induction, training of staff (paid and unpaid), effective communications and support mechanisms in relation to Safeguarding.

## **7. Professional Boundaries**

Nailsworth Town Council expects staff to protect the professional integrity of themselves and the Council.

## **8. Reporting**

The process outlined below details the stages involved in raising and reporting safeguarding concerns at Nailsworth Town Council:

- Communicate your concerns with The Clerk or the Personnel Committee
- Seek medical attention for the vulnerable person if needed
- Discuss with parents of child or with vulnerable person
- Obtain permission to make referral if safe and appropriate
- If needed seek advice from the Children and Families helpdesk or Adults helpdesk
- Complete the Local Authority Safeguarding Vulnerable Groups Incident Report Form if required and submit to the local authority within 24 hours of making a contact

- Ensure that feedback from the Local Authority is received and their response recorded

If the immediate manager is implicated, then refer to the Personnel Committee

## **9. Allegations Management**

Nailsworth Town Council recognises its duty to report concerns or allegations against its staff (paid or unpaid) within the organisation or by a professional from another organisation.

The process for raising and dealing with allegations is as follows:

**First step:** Any member of staff (paid or unpaid) from Nailsworth Town Council is required to report any concerns in the first instance to the clerk/personnel committee. A written record of the concern will be completed by the Clerk/Personnel Committee.

**Second step:** Contact local authority for advice. In Gloucestershire this can be done via (for children) the Safeguarding Children Services Local Authority Designated Officer (LADO) 09452 426994, or (for adults) the Adult Helpdesk 01452 426868.

**Third step:** Follow the advice provided

The full local authority process can be sourced as a flow chart from [www.gsrb.org.uk](http://www.gsrb.org.uk) (for children).

Nailsworth Town Council recognises its legal duty to report any concerns about unsafe practice by any of its paid or unpaid staff to the Independent Safeguarding Authority (ISA), according to the ISA referral guidance document <http://www.isa.gov.org.uk/PDF/ISA%20Referral%20Guidance%20%20V2009-02.pdf>

## **10. Monitoring**

The organisation will monitor the following Safeguarding aspects:

- Safe recruitment practices
- DBS checks undertaken and reviewed
- References applied for new staff
- Records made and kept of supervision sessions
- Training – register/ record of staff training on child/ vulnerable adult protection
- Monitoring whether concerns are being reported and actioned
- Checking that policies are up to date and relevant
- Reviewing the current reporting procedure in place
- Presence and action of The Clerk responsible for Safeguarding is in post

## **11. Managing Information**

Information will be gathered, recorded and stored in accordance with the following policies Data Protection Policy, Confidentiality Policy.

All staff must be aware that they have a professional duty to share information with other agencies in order to safeguard children and vulnerable adults. The public interest in safeguarding children and vulnerable adults may override confidentiality interests. However, information will be shared on a need to know basis only, as judged by the Clerk.

All staff must be aware that they cannot promise service users or their families/ carers that they will keep secrets

## **12. Conflict resolution and complaints**

Nailsworth Town Council is aware of the GSCB policy on resolution of professional disagreements in work relating to the safety of children/Escalation Policy (at [www.gscb.org.uk](http://www.gscb.org.uk) ) and if necessary this will be taken forward by The Clerk/Chair of Personnel Committee.

Conflicts in respect of safety of vulnerable adults will be taken forward by The Clerk/Chair of Personnel Committee via the GCC Community and Adult Care Directorate.

## **13. Communicating and reviewing the policy**

Nailsworth Town Council will make clients aware of the Safeguarding Policy through the following means:

- A statement to Hirer's posted on the Notice Boards and Website noting that acceptance of the Town Hall's safeguarding policy is part of the agreed contract taken out on hiring the Hall.
- Providing, if requested, a written copy of the policy, providing a link to the Web site where it will be available

This policy will be reviewed by Personnel committee every year and when there are changes in legislation. Appendix 1 is a simplified notice referring to this policy which is suitable for the notice board and website.

The policy seeks to ensure that Nailsworth Town Council undertakes its responsibilities with regard to protection of children and/or vulnerable adults and will respond to concerns appropriately.

Safeguarding is about embedding practices throughout the organisation to ensure the protection of children and vulnerable adults wherever possible. All children and vulnerable adults have the right to protection from abuse whether physical, verbal, sexual, emotional, bullying, neglect or financial.

All people associated with the Town Hall and its use have a responsibility for the safeguarding of children and vulnerable adults.

No paid or unpaid staff will have unsupervised access to children or vulnerable adults unless in possession of appropriate DBS clearance.

Acceptance of the Town Hall's safeguarding policy is part of the agreed contract taken out on hiring the Hall.

Hirers need to be aware that facilities such as the toilets might be shared with other groups and that appropriate supervision/arrangements should be made.

The Town Council will ensure that hirers are made aware of their obligations under the Licensing Act 2003 to ensure that alcohol is not sold to those under the age of 18. The committee will ensure that hirers are aware that no children may be admitted to films when they are below the age classification for the film or show.
